## **Written examinations dates:**

## 1. FC Rad Onc Part 2:

- a. FS End Jan/Beg Feb,
- **b.** SS Beg July

## 2. FC Rad Onc: Part 1:

- a. FS Mid/end Feb,
- **b.** SS Mid- End July

#### Dates of OSPE/ oral:

- FS May
- SS Sept/Oct- 2<sup>nd</sup> week Oct preferable
- 1. The president/secretary will submit panels for examinations to CMSA at least 6 months, and preferably a year prior to the examination.
- 2. Invitations to be examiners will be sent out via the CMSA offices by the following dates.

#### **Standard setting panels**

- Will include only qualified radiation Oncologists who are involved in academic registrar training AND who have been trained in standard setting OR who have attended a SS as an observer previously
- SS panel will include at least 8-10 examiners from a cross section of universities
- SS panel will include at least 2-3 experienced examiners
- Examiners may exclude themselves from SS on a paper they have set if there are a minimum of 80ther examiners present
- Moderators will read out questions and will not score on papers they have moderated provided a minimum of 8 examiners are present.

# **Standard setting procedure:**

- Moderator will liaise with CMSA(Bianca v/d Westhuizen to identify available dates
- Moderator will liaise with president regarding panels
- CMSA will send out panelist invites 1 month prior to SS.
- SS will happen withing 3 days of the written examinations
- Part 2, Paper 1 is a single SS mark

- Papers 2 & 3 are assessed together and presented as a single mark for SS (since they are 2 parts of a single body of knowledge)
- For Part 1 and Part 2, the lowest pass mark out of median mark and average mark will be the pass mark.
- Where a single examiner sets a level more than 10% above or below the minimum or maximum, then the moderator may elect to exclude that mark as an outlier provided there are a minimum of 8 other examiners on the panel.
