

 - Indicate in detail how you would set about choosing one particular therapy. ii) (25)
 - A paper published in 2004 by Papageorghiou et al showed that the use of second b) trimester uterine artery Doppler screening had a pooled positive Likelihood Ratio of 5.9 (95% confidence limits 5.3 to 6.52) and a negative Likelihood Ratio of 0.55 (95% confidence limits of 0.5 - 0.6) for the diagnosis or pre-eclampsia (15)

 - c) Discuss the clinical applications and utility of assessment of flow patterns in the ductus venosus.

 - c) Discuss your approach when detecting a facial cleft at the detail scan.
